

Kennywood's Colossal Hot Chocolate Cup Sweepstakes ("Sweepstakes")

Official Rules

ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Sweepstakes is offered only in the fifty (50) United States. Void outside of the 50 United States, in the District of Columbia, Puerto Rico and where prohibited or otherwise restricted by law. The potential winner will be required to confirm his/her mailing address for receipt of a notification letter and paperwork delivery.
